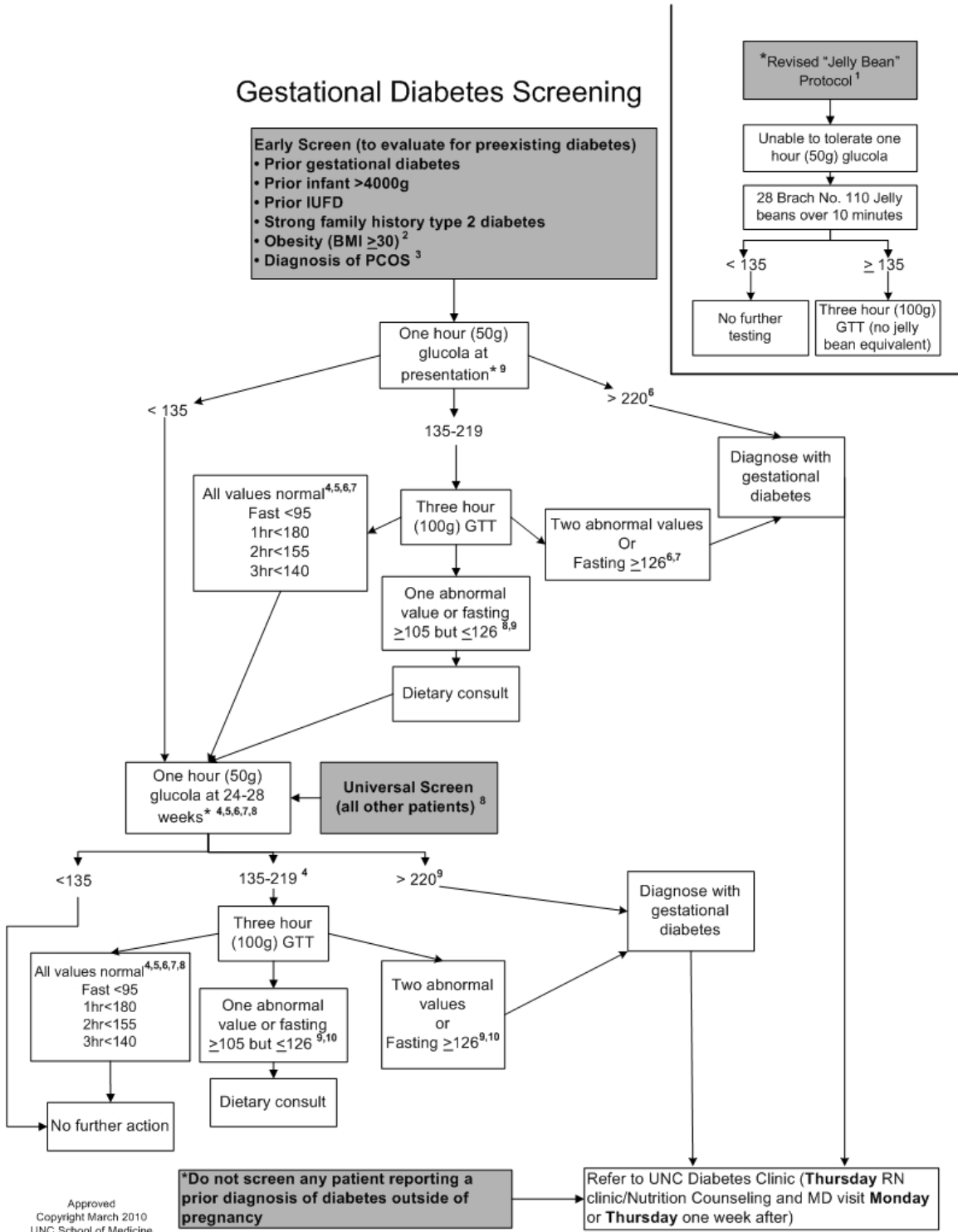


Gestational Diabetes Screening

Jelly beans as an alternative to a fifty-gram glucose beverage for gestational diabetes screening. **Am J Obstet Gynecol** 1999; **181: 1154-7**. *A prospective cohort study of 136 pregnant women showed consistency between one hour glucose values after 28 jelly beans (50g simple carbohydrate) and 50g Glucola.*

A fasting plasma glucose level >126 meets the threshold for diagnosis of diabetes if confirmed on a subsequent day.*

Is the 50-gram glucose screening test ever diagnostic? **J Mat-Fet Med 1996; 5:317-20.** *All subjects with a 50g screen >216 had evidence of GDM and required insulin for glycemic control. Patients with a 50g screen >220 do not all require a 3hr GTT. Those with a fasting glucose >140 may begin diet and/or medication therapy.*

Does insulin secretion in patients with one abnormal glucose tolerance test value mimic gestational diabetes mellitus? **Am J Obstet Gynecol 2002; 186.** *A prospective controlled study of 110 women demonstrated similarity in fasting insulin levels and insulin resistance between women diagnosed with GDM by standard criteria and women with one abnormality on 3 hour GTT.*

Management of women with one abnormal oral glucose tolerance test value reduces adverse outcome in pregnancy. **Am J Obstet Gynecol 1989; 161:593-9.** *A RCT including 126 patients with abnormal value on GTT and 146 women in the control group: comparison between the control and the untreated groups showed a significantly higher incidence of large infants and metabolic complications.*
